**Instructions for the candidates: -**

- a) The candidates to contact on [FCFPA@dlcsupva.ac.in](mailto:FCFPA@dlcsupva.ac.in) for any official communication.
- b) The candidate must read the HSTES B.Tech/B.Arch. Prospectus 2025-26 carefully. **The candidates are required to report in the University offline, with full 1<sup>st</sup> semester fee (B.Arch.)**
- c) The offline admission process will be completed only after payment of 1<sup>st</sup> semester admission fee in full after due verification of documents.
- d) The candidates shall not be allowed to participate in offline counseling without submission of required documents and the payment of 1<sup>st</sup> semester admission fee in full.
- e) The provisionally admitted candidates, **at the time of reporting in the institute must bring the following** Original Certificates/ Documents/ Testimonials. Any candidate, who fails to produce any of the required Certificate/ Documents/ Testimonial at the time of reporting the institute, will forfeit his/ her claim to admission as per HSTES B.Tech/B.Arch. Prospectus 2025-26 without fail and Annexures present within prospectus in HSTES B.Tech/B.Arch. Prospectus 2025-26 is mentioned below:
  1. Qualifying Examination i.e. 10+2/Intermediate/ Senior Secondary School Examination.
  2. Matriculation/ High School Certificate.
  3. JEE (Main) – 2025 rank card / NATA-2025 Score Card.
  4. Character Certificate:
    - a) Regular Candidates: The candidates who passed their qualifying exam. From School/ College as regular students are required to submit the Character Certificate as per **Annexure-I**.
    - b) Private Candidates: Candidates, who have passed the qualifying examination as private candidates should submit their Character Certificate, duly signed by a First Class Magistrate.
  5. Residents Certificate, if applicable: Candidates, who have passed their qualifying examination from a Board/ Recognized School located in the State of Haryana will be deemed to be Haryana residents and will not be required to submit certificates of bonafide residents of Haryana.
  6. Certificate from the Employer in the case of Employees of Govt. of Haryana, members of All India Services born on Haryana Cadre, Employees of Statutory Bodies/ Corporations as per **Annexure-II**, if applicable.

7. Scheduled Caste Certificate should be verified from PPP Data base, if applicable.
8. Deprived Scheduled Caste Certificate should be verified from PPP Data base, if applicable
9. Backward Class Certificate should be verified from PPP Data base, if applicable and income certificate should be verified from PPP Data base.
10. Economically Weaker Section (EWS) income and asset certificate as per **Annexure-XI**.
11. Certificate in respect of Divyang Candidates should be verified from PPP Data base as per **Annexure-III**, if applicable. \*The handicap disability should not be less than 40% 54 and should not interfere with the requirement of professional career such as Pharmacy/Engineering/Architecture/Technician etc.
12. Certificate required to be furnished by the Children & Grand – children of Freedom Fighters as per **Annexure-IV**, if applicable.
13. Certificate from wards of Deceased/ Disabled/ Discharged Military/ Para Military Personnel/ Ex-Servicemen or Ex-Personnel of Para-Military Forces Annexure-V.
14. Certificate from wards of ex-employee of Indian Defense Services/ Para Military Forces- **Annexure-VI**.
15. Certificate of Medical Fitness- **Annexure-VII**.
16. Admit Card of JEE (Main)-2025/ NATA-2025 (B. Arch.)
17. Annual parental income from all sources (in case of TFW quota candidates) should be verified from PPP Database.
18. Undertaking of Anti-ragging by the student **Annexure-VIII**.
19. Undertaking of Anti-ragging by the Parent/ Guardian **Annexure-IX**.
20. Aadhaar Number. It has been decided by the Government that from the session 2019-20 onwards, the candidate shall submit preferably the Aadhaar Number (or Enrolment No.) at the time of online registration. Coloured Photograph (JPG File Max. 30KB Size) and Signatures of candidate (JPG File Maximum 20 KB Size)
21. Parivar Pehchan Patra for Haryana Residents.
22. Income & Asset Certificate (EWS) as per Annexure-XI and income should be verified from PPP Data base.
23. Proof of Registration Fees paid.
24. Seat Allotment letter.
25. **Migration Certificate.**
26. Gap year affidavit (if applicable).
27. **Three (03) Passport size Photographs of the candidate**

**Note:**

- i. **All Originals and 3 sets of attested photo-copies of all applicable documents/ testimonials/ certificates must be brought at the time of physically joining/ reporting the institute.**
- ii. The original certificates shall be returned back after verification by the institute.
- iii. The 3 sets of attested copies of certificates/ documents/ testimonials will be verified & signed by the Director-Principal or his authorized representative & will be retained for registration purposes with the HSTES and subsequently in the University.
- iv. In case of Kashmiri Migrants, supporting certificates and original certificate of migration duly signed by the competent authority or Relief Commissioner along with the printout of online- filled application form.

- v. In case of HGST, candidates shall produce a certificate, as per Annexure X, in the support of their claim from the Principal/ Headmaster of the Govt. School of which the candidate is topper clearly stating the strength of class.
- vi. Only those candidates whose parental/ Guardians annual income from all sources does not exceed Rs. 8.00 Lacs can apply for TFW category by verifying Annual Family income from PPP ID Database.
- vii. Admission Data Management Fee (Rs. 200/- per admission) shall be charged one time by HSTES in respect of all admissions (Centralized Admissions and Institute Level Admissions) in Self-Financing Institutions including un-aided branches of Aided Institutions from the academic session 2016-17 onwards. The said Fee be charged from the admitted students by the concerned institute and be credited/ deposited in HSTES account.
