With the approval of the competent authority, the applications for **Ramkalawati Mann Scholarships** are invited from the eligible students of PLCSUPVA, Rohtak, satisfying the following conditions: -

### Conditions to be satisfied by a student for being eligible for the above scholarships

- 1. Family income from all sources should not exceed Rs. 3.00 lac, for which production of income certificate from the Revenue Authorities is compulsory.
- 2. Production of Domicile of the concerned state is compulsory.
- 3. Student must have cleared his/her all the previous examinations obtaining minimum 50% marks.
- 4. Student must be regular in the classes and having good conduct certificate by the HoD/FC.
- 5. Student must be having an individual bank account to enable the University transfer the amount of the scholarship to his/her account by NEFT/RTGS.
- 6. Students availing of any scholarship/financial aid from any quarter will not be eligible for this Scholarship.

In this regard, the eligible students are instructed to submit the above-cited Application Form in the prescribed proforma only, complete in all respects, directly to the Office of the DSW, latest by 10.05.2023. No application form will be entertained after the expiry date mentioned above. The interviews of the eligible candidates, submitting the applications within the prescribed period, will be conducted on 25.05.2023 at 11.00 a.m. in the room of the DSW. All eligible candidates must bring their original documents at the time of interview.

The prescribed proforma of the application form is attached herewith, which is available on the University's website.
