7. 1. TIME AND DATE FOR RECEIPT AND OPENING OF THE QUOTATIONS:

3. NUMBER OF JOURNALS/ MAGAZINES:

Number of journals/magazines may increase or decrease by 15%. The rate of discount offered will be applicable to new subscriptions also i.e. journals added in subsequent years of subscription within the limit of 15%, if any.

4. VALIDITY OF QUOTATION:

The quotation must be valid for a period of at least three months from the date of its opening.

5. DISCOUNT:

Uniform rate of discount must be quoted for all the journals/magazines, separately for Indian and foreign, for all three years. The period of subscription may be increased for another two years depending upon the satisfactory service. Discount offered will be applicable on the price of the journal/ magazine printed in either last issue(s) of the current year or first issue(s) of the year

for which subscription will be paid or the publisher's invoice. **Same discount will be applicable for the entire period of subscription including the new editions.**

6. EXCHANGE RATES:

Bank Exchange Rates on the date of billing shall be applicable.

7. ONLINE SERVICE/INTERNET ACCESS:

In case the publisher(s) offer **FREE** online access with print subscription to their journals/magazines, the Agency shall provide IP address (s) to the University Library, PLCSUPVA, Rohtak, for availing of free online access facility.

8. PLACE, FREQUENCY AND MODE OF SUPPLY:

The journals/magazine shall be delivered regularly at the University Library, PLCSUPVA, Rohtak by registered post/ by hand/ by courier at the cost of the agent/publisher/vendor etc.

9. MISSING (UNSUPPLIED) ISSUES/ SERVICE-NOT-STARTED CASES:

The appointed Agency shall replace the missing/unsupplied issues at their own cost, or refund costs thereof on pro rata basis. The Agency shall also refund the subscription cost of all service-not-started cases in full. Time to complete the supply of journals/magazines shall be **30th July of the subsequent year i.e. year next to the year for which an order is placed.**

10. SECURITY/EARNEST MONEY (REFUNDABLE):

11. BANK GUARANTEE (BG):

The Agency appointed for supply of journals/magazines shall furnish Bank Guarantee (BG) of Rs. 55000/- (Fifty five thousand only) at the rate of 5% of the estimated value of the order to the University to cover up the risk of missing/unsupplied issues and service-not-started cases. The BG must be valid upto **31st December of the subsequent year i.e. year next to the year for which order is placed.** The BG should be drawn in favour of the Registrar, Pandit Lakhmi Chand State University of Performing and Visual Arts, Rohtak and should be submitted with the first invoice to be submitted by the Agency for reimbursement, failing which invoice shall not be admitted. The amount of BG shall be forfeited, if the Agency fails to refund the outstanding dues within the period prescribed under **Clause 8** of this document.

12. CANCELLATION OF ORDER:

The PLCSUPVA, Rohtak reserves the right to cancel the order(s) for any journal/magazine without assigning any reason thereof before the remittance is made by the Agency to the Publisher(s)

13. REPUTATION AND EXPERIENCE OF THE FIRM: The agency quoting the rates and other terms and conditions must have good reputation and at least three years' experience in the subscription of journals/magazines for Indian libraries. Firms with less than 50 lakhs Annual Turn Over (for the preceding 03 years) w.r.t. Journals/magazines subscription/ supply of books will not be eligible to participate in the bid. The following documents/information must be furnished with the quotation to prove the credentials:

- i. List of quotee's client libraries in India.
- ii. Proof of supply of journals/magazines/ books to Indian libraries during the last three years.

- iii. Documentary proof for the establishment of vendor under Shop Act or any other such central/state Act or membership of All India Federation of the Associations of Booksellers and Distributors.
- iv. Proof of preceding 03 years' Annual Turn Over.(not less than 50 lakhs per annum).
- v. Copies of PAN/TAN/GSTN and Income Tax clearance certificate.
- vi. State whether the agency has its own office in Europe/USA. If yes give address.

14 RIGHT TO ACCEPT/REJECT THE QUOTATIONS:

The right to accept the quotations shall rest with the Committee constituted by the Vice-Chancellor. The Committee does not bind itself to accept the lowest quotation and reserve the right to reject any or all items of quotations without assigning any reason thereto. The Committee also reserves the right to accept quotations in part i.e. any item or any quantity and to reject it for the rest.

15. CERTIFICATE OF NON-DEBARMENT:

The Agency participating in the bid/ tender shall append a certificate that it has not been debarred/blacklisted for any reason/ period by any library of Central Govt. Dept./State Govt. Dept./University/Institute/College. If debarred, particulars of the same may be furnished.

16. AGREEMENT:

The Agency appointed for supply of journals/magazines shall enter into a binding agreement with the authorised officer of PLCSUPVA, Rohtak for the execution of the order wherein all the obligations of both the parties shall be spelt out.

17. PENALTY:

In case the Agency fails to execute the supply order on the agreed discount, and terms and conditions as contained in the Order/Agreement, it shall be liable to such action as blacklisting, debarment from having any business with this University, forfeiture of earnest money/security, besides any other action as may be deemed proper by the University.

18. TERMS AND CONDITIONS PRINTED ON QUOTATION/INVOICE:

Terms and conditions printed on Quotation/Invoice of the appointed Agency, if any, shall not be binding on the University. Acceptance of the order by the Agency shall be construed that it is the Agreement with all the terms and conditions contained in the Agreement referred to in **Clause 15** of this document.

19. JURISDICTION:

The disputes, if any, shall be subject to jurisdiction of Rohtak Courts. Any other Jurisdiction mentioned in the quotations/invoices shall be invalid and shall have no legal sanctity.
