Sr. No.	Particular	Schedule
1.	Submission of fee	15 days w.e.f. commencement of semester i.e. 10.07.2023
2.	Submission of fee with late fee of Rs.500/-	10 days after completion of above schedule at Sr. No. 01. After that name will be struck off. The students who have not submitted their fee, wouldn't allow to attend the classes.
3.	Re-admission with a fine of Rs.100/- per day from the date of commencement of semester.	Upto two weeks after completion of above schedule at Sr. No. 02, with the permission of Dean Academic Affairs.
4.	Re-admission with a fine of Rs.100/- per day from the date of commencement of semester.	After completion of above schedule at Sr. No. 03, the admissions will be allowed with the approval of the Vice Chancellor in extreme case on valid justification & recommendation of HoD and Faculty Coordinators

All the Faculty Coordinators are requested to direct respective Heads of Teaching Departments to adhere with the above schedule for upcoming semesters and to intimate students accordingly. The concerned HOD will notify the list of students whose name got struck off and send a copy to DAA/COE and Accounts Branch. No other fee notice will be issued separately.
