- 1. - 3. Provisional admissions shall be done on the basis of online submission of application form and relevant documents admission shall be regularized only after the verification of the original documents.
- 4. Applicant shall be responsible for any discrepancy found at any stage of the admission process and even later. Inthat case, the admission shall be liable for cancellation and it may also invite appropriate action as per law.
- 5. 50% tuition fee concession in fee for the Internal Students of DLCSUPVA & students of HWSPSHI (Haryana Welfare Society for Persons with Speech & Hearing Impairment, Wards of Regular Faculty & Staff of DLCSUPVA and Dept. of Technical Education, Haryana.
- 6. 40% tuition fee concession of fee For the Regular Faculty & non-teaching staff of DLCSUPVA and Dept. of Technical Education, Haryana and staff of HWSPSHI (Haryana Welfare Society for Persons with Speech & Hearing Impairment)
- 7. Any dispute if rises, will be referred to Admission Grievance committee and the recommendations of the committee in this regard, post the approval of the Vice-Chancellor shall be final.
- 8. Before seeking admission, candidates are required to consult the updated list of examinations recognized by the Board of School Education, Haryana, Bhiwani. In case during scrutiny of at a later stage, examination passed by the candidate is found unrecognized by the board, his/her candidate is liable to be cancelled.
- 9. The candidates are required to go through the instructions available in the prospectus before depositing the fee.
