Important Instruction:-

- 1. The provisionally admitted candidates shall be required to submit the Original documents along with two sets of photocopies, Anti-Ragging Affidavit (candidate and parents), Medical Certificate, Income Certificate, Family ID etc. on or before 27/07/2023 in the department for further processing by the University, failing which the admission shall stand cancelled automatically.
- 2. Fee will be paid offline/online on the link supplied by the University on its website within prescribed time limit, i.e. 22/07/2023 to 27/07/2023.
- 3. Provisional admissions shall be done on the basis of online submission of application form and relevant documents admission shall be regularized only after the verification of the original documents.
- 4. Applicant shall be responsible for any discrepancy found at any stage of the admission process and even later. In that case, the admission shall be liable for cancellation and it may also invite appropriate action as per law.
- 5. A candidate seeking admission in Haryana category or availing 50% concession on account of being Haryana female student has of submit a domicile certificate.
- 6. Any dispute if rises, will be referred to Admission Grievance committee and the recommendations of the committee in this regard, post the approval of the Vice-Chancellor shall be final.
- 7. Before seeking admission, candidates are required to consult the updated list of examinations recognized by the Board of School Education, Haryana, Bhiwani. In case during scrutiny of at a later stage, examination passed by the candidate is found unrecognized by the board, his/her candidate is liable to be cancelled.
- 8. The candidates are required to go through the instructions available in the prospectus before depositing the fee.
