Sub:- Inviting Applications from the Eligible Girl Students of DLCSUPVA, Rohtak for Grant of Sh. B.P. Jain Scholarships to Two of the Deserving Girl Students Belonging to Haryana State for the Session 2023-24 - Reg.

The applications for grant of Sh. B.P. Jain Scholarships are invited from the eligible girl students of DLCSUPVA, Rohtak belonging to Haryana State satisfying the following conditions:-

Conditions to be satisfied by a student for being eligible for the above scholarships

- She should be resident of Haryana, for which production of Haryana Domicile 1. Certificate is compulsory.
- Family income from all sources should not exceed Rs. 3.00 lac, for which production of 2. income certificate from the Revenue Authorities of Haryana is compulsory.
- She must have cleared her all the previous examinations obtaining minimum 50% 3.
- She must be regular in the classes and having good conduct certificate by the 4. HoD/FC.
- She must have an individual bank account to enable the University for transfer of the 5. amount of the scholarship to her account by NEFT/RTGS.
- Students availing of any scholarship/financial aid from any quarter will not be eligible 6. for this scholarship.

In this regard, the eligible students are instructed to send the above-cited Application Form in the prescribed pro forma only, complete in all respects, directly to the Office of the DSW, latest by 10.10.2023. No application form will be entertained after the expiry date mentioned above. The interviews of the eligible candidates, submitting the applications within the prescribed period, will be conducted on 17.10.2023 at 10.30 a.m. in the room of the DSW.

The prescribed proforma of the application form is attached herewith, which is available on the University's website.

This is issued for urgent compliance on priority basis.


