2. ABOUT THE UNIVERSITY

Pandit Lakhmi Chand State University of Performing & Visual Arts, Rohtak, came into existence on August 5, 2014 through Haryana Act No. 24 of 2014 by integrating four government technical institutions, namely, State Institute of Fine Arts (SIFA), State Institute of Design (SID), State Institute of Film & Television (SIFT) and State Institute of Urban Planning & Architecture (SIUPA).

The university is spread over 40 acre of land, beautifully designed with a healthy, verdant campus. It is centrally located in the state of Haryana, at a distance of about 70 kms from the national capital, 90 kms from IGI Airport and 220 kms from Chandigarh, and is well-connected with the road and railway network. With magnificent buildings and state-of-art infrastructure, it has spacious seminar halls, laboratories, workshops and studios, well-equipped with latest machinery and equipment. Central facilities like auditorium, seminar halls, central library, etc. are also available for academics and extra-curricular activities. A girls' hostel with a capacity to accommodate 170 students is already available in the campus. Housing facility for both faculty and non-teaching staff is likely to commence shortly.

Presently, there are four faculties in which 14 undergraduate degree level programmes are being offered; four in the Faculty of Fine Arts, four in the Faculty of Design, five in the Faculty of Film & Television and one in Faculty of Urban Planning & Architecture. Besides, Post-Graduate programmes had been started in each faculty since the last academic session (2019-2020). These new programmes are: Master in Fashion Design, Master of Applied Arts, Master in Mass Communication (Media Production) and Master of Planning (Urban & Regional). 14 diploma and certificate courses are also being planned from the current session (2020-21).

The State Govt. has also planned to setup a Regional Centre of the university in village Aterna, Distt. Sonepat, in which various courses of humanities and social sciences, including cultural and folk media studies, are also likely to be introduced in the near future.

UNIVERSITY LIBRARY

The library is the hub of all academic and research activities and plays an important role in the pursuit of these goals of its parent organisation. Richness of library's learning resources collection and their use by the students and the teachers are among the important indicators for assessment of quality of education its parent body provides and research output it produces. Until recently, this library was in dormant state owing to acute shortage of staff both at professional as well as non-professional levels, adequate financial allocation and other factors. It is now striving hard to emerge from its infant and dormant state and has started assuming the responsibility which a library is expected to discharge. The achievements of the library made during the period of the report, despite hard times due to covid-19, are unfolded in the following pages.

1. Library Staff:

The university budget portrays 12 posts of library staff— 01 post of University Librarian, 03 posts of Asstt. Librarian, and 08 posts of Library Asstt—out of which only one post of Library Asstt. stands filled on regular basis. As a stop-gap arrangement for running the library services, the university has engaged a Library Consultant, 01 Asstt Librarian, 01 Junior Librarian, 02 Library Asstts., 03 Library Attendants and 01 Peon under its outsourcing policies.

2. Library Budget:

A sum of Rs. 21,26,802/- was spent on the enrichment of knowledge resources base of the library in various forms such as books, journals and e-resources.

The lockdown forced by Covid 19 led to drastic plunge from 16607 during the same period last year to 4093 in the In-person use of library resources. However, check-out check-in transactions showed some improvement.

In order to provide necessary assistance to the students in their academic pursuits during this difficult time, this library rose to the occasion and provided remote access to the digital resources, namely, "Art & Architecture Complete", NDLI, DOAJ etc. to its stakeholders.
