**OFFICE ORDER**

In term of Statute 29(2) of University Act, the Vice- Chancellor has been pleased to constitute Under-graduate Board of Studies (UGBOS) of the Department of **Fashion & Lifestyle Design** as under: -

- (ii) The Chairperson of Departments - **Sh. Satish Kumar, Assistant Professor**
- (iii) One Professor nominated or recognized by the University in the Department, to be nominated by the Vice-Chancellor by rotation, according to seniority - **Vacant**
- (iv) One Associate Professor and one assistant Professor nominated or recognized by the University in the Department, to be nominated by the Vice-Chancellor, by rotation, according to seniority.

Provided that no such teacher shall be nominated for two consecutive terms:

Provided further that a teacher who has been nominated as a member of the Faculty shall not be nominated under this sub clause-

- (v) Two outside experts nominated by the Vice Chancellor on the recommendation of the Chairman of the Department:

- I) **Mr. Anil Kumar, Asst. Professor, FDDI (Ministry of Commerce, Govt of India), Rohtak**
- II) **Sh. Milind Khurana, Senior UX Designer, Smart Energy Water, New Delhi**

**NOTE:**

- i. The Board of under-graduate studies shall recommend to the Academic Council, through the Faculty concerned, course and syllabi of studies and text books for the various subjects for under-graduate courses.
- ii. The Board of studies shall also make recommendations to the Academic Council, regarding the appointments of paper-setters and examiners for the under-graduate.
- iii. The Board of studies shall deal with any other matter that may be referred to them by the Faculty. The Chairperson of the Department shall be the Chairperson of the Board. Members, other than ex-officio members, shall hold office for a period of two years.

Provided that a person whose book or any other publication is to be the subject of consideration before the Board, shall not be attached to the Board.
