OFFICE ORDER

In term of Statute 29(3) of University Act, the Vice- Chancellor has been pleased to constitute Post-graduate Board of Studies (PGBOS) of the Department of Fashion Design as under:-

- (i) Dean of the institution - **Dr. Ajay Kaushik, Dean Academic Affairs**
- (ii) the Chairperson of Departments - **Dr. Shelly Khanna, Associate Professor**
- (iii) all Professors nominated or recognized by the University in the Department - **Vacant**
- (iv) two Associate Professors and two Assistant Professors nominated or recognized by the University in the Department, to be nominated by the Vice-Chancellor, by rotation, according to seniority - **Vacant**
- (v) two teachers including the Heads of the post graduate Departments in the institutions in the subject concerned with at least ten years teaching experience to be nominated by the Vice-Chancellor, by rotation, according to seniority to be determined by the length of post-graduate teaching experience.
Provided that not more than one such member shall be from the same institution;

- (vi) two outside experts to be nominated by the Vice-Chancellor on the recommendation of the Chairman of the Department:

I. Sh. Pradeep Swami, Sportking Textile Ltd. Bathinda, Punjab

II. Dr. K.N. Chatterjee, Visiting Professor, Department of Design, NSUT, Delhi

NOTE:

- i. The Board of under-graduate studies shall recommend to the Academic Council, through the Faculty concerned, course and syllabi of studies and text books for the various subjects for under-graduate courses.
- ii. The Board of studies shall also make recommendations to the Academic Council, regarding the appointments of paper-setters and examiners for the under-graduate.
- iii. The Board of studies shall deal with any other matter that may be referred to them by the Faculty. The Chairperson of the Department shall be the Chairperson of the Board. Members, other than ex-officio members, shall hold office for a period of two years.

Provided that a person whose book or any other publication is to be the subject of consideration before the Board, shall not be attached to the Board.
